

Bishop Peter Carrell's Presidential Address, Synod, 11/09/2020

This is the full, official text of the Address. For the Zoom Synod itself, under time constraint, a briefer version will be verbally delivered.

Introduction

In the Christian movement Jesus catalyzed into life and growth through history there are moments when we pause to take stock.

Every synod is a pause in the life of a diocese.

In our Synod our reports and bills and motions as I read them are properly about a Diocese taking a moment to pause, to review, to take stock, to ask whether we are heading in the right direction – the direction, that is, which is faithful to the call of Jesus to fish for people, and the direction which is never satisfied until we see the fullness of the kingdom of God.

My address to you is also part of pausing to reflect on where we are going.

It is an opportunity for me to share with you my vision for the future and proposed strategic themes as I lead you, having been called by God through you to be your bishop.

But this year our pausing for collective reflection, review and decision making is brand new (our first Synod by Zoom) and in the midst of a year which has repeatedly made a mockery of the best laid plans of governments, corporations, educational institutions, sports bodies and churches to make a plan and to stick to it.

In this crazy time we will do our business as a Synod assuming that sometime soon life will return to a new normal of meeting physically together, without Covid inspired limitations.

At the end of Luke 5, Jesus talks about new and old things. Reading from verse 36 we find:

No one tears a piece from a new garment and sews it on an old garment; otherwise the new will be torn, and the piece from the new will not match the old. (36)

And no one puts new wine into old wineskins; otherwise the new wine will burst the skins and will be spilled, and the skins will be destroyed. (37)

But new wine must be put into fresh wineskins. (38)

And no one after drinking old wine desires new wine, but says, "The old is good." (39)

There is a sense in which all our talk of the Regeneration of the Diocese has characteristics of "the new" and thus we wonder what "new wineskin" of a Diocese we need for our new future.

But this year, exemplified by this Zoom format for meeting as a Synod, we have had some new wine and a new wineskin, virtual church, forced on us by the Pandemic. An irony of the situation is that many of us find ourselves appreciating verse 39: "The old is good", meaning, bring back physical meeting together, with hugs and handshakes, with communion in two kinds and biscuits and cake for morning tea!

The Diocese of Christchurch, 2019-2020 – Part A

Gratitude

I begin this part of the address by saying, “Thank you.” Praise and thanks to God who has called us into being as a Diocese and who continues to work among us and with us. Through God we have been blessed in the past year in many ways.

It is also appropriate to offer our human thanks to those who have done so much for us.

Thus, on behalf of the Diocese, I thank the many people, clerical and lay, paid and unpaid, elected or appointed, who have worked so hard over the past year and who make the Diocese of Christchurch what it is.

The list is extensive, it is readily found across the pages of our Diocesan prayer cycle, but it is not limited to those whose names appear in the cycle.

I work very closely with some on the list. There are more than a dozen names in this category, I will not list you all, but you know who you are: thank you, thank you, thank you.

I also warmly thank the following people who are leaving one of our three major Boards in the Diocese:

CPT: Bruce Deam, Lisa-Marie Richen.

I also warmly thank our Chancellor, Jeremy Johnson, who is leaving this role after an intense period of work over many years, from 2008 to 2015 as Vice Chancellor and from 2015 to this Synod as Chancellor. Later in the Synod we will acknowledge Jeremy’s work more fully.

Finally, in this section, I want to say thank you to Teresa for her loving support through this past year. I could not do this job without you!

Disaffiliation

A year on from my lament at Synod about Disaffiliation, I acknowledge that the consequences remain with us, despite significant commitment on the part of several ministry units to move forward into a new future – commitment which I honour and applaud.

One such consequence I mention here is the importance at this Synod of embedding into the Diocesan network of ministry units a revised and enlarged Parish of Shirley which incorporates the districts of Burwood and Marshlands. I thank the parishioners of Shirley and Each Christchurch parishes for their great efforts to bring the proposed resolution to this Synod.

Recovery

Through 2019-2020 great progress has been made on our Recovery Programme – our programme for repairing, restoring and re-strengthening buildings across the Diocese which were damaged in the earthquakes in 2010, 2011 and 2016.

This year the **Reinstatement of the Cathedral** has included progress towards 100% Concept Design, which we hope can be made public before the end of October, and the beginning of Stabilization Work on the building itself.

There will be a presentation on this project as a separate item on our order paper. Here I simply note that this project is both a pleasure for me (because I meet and work with some wonderful people associated with this project) and a significant demand on my diary (there are lots of meetings and emails to attend to). Through Lockdown this year we made considerable progress on the concept design for the project. In the past month or so we have seen considerable progress on site as work on stabilization has begun.

In respect of the overall Recovery Programme, we have determined that most of it will be completed by 31 March 2021. A few projects will take a few more months to complete. A few projects are effectively on hold due to shortage of required finance, such as St John's, Hororata and St John the Evangelist Church, Okains Bay.

At other moments in our Synod timetable we will have time to consider various matters to do with the Cathedral Reinstatement and our Recovery Programme, but here I want to acknowledge the hard work CPT, parish, CCRL and CCRT staff, vestry and Board members have put into making things happen, including raising much needed funds for work to proceed. Thank you.

Property and Mission

Last year in our Synod we had a few motions concerning assets, especially property in relation to our participation in the mission of God. I said then, in my Presidential Address,

“I see these motions as representing some frustration, some dreaming and some aspirations to be better resourced in our gospel mission. I hear, as you likely do also, some talk about how we might better deploy assets across our Diocese for a better focused mission.”

This year we have an opportunity to move forward on property and mission matters. First, by formally withdrawing last year's motions which were laid on the Synod table. Secondly, by discussing and then voting on a motion which, if agreed, would become part of the Guidelines of the Diocese in respect of property. The motion broadly speaking compels no ministry unit to do what it does not want to do but presses on every ministry unit the importance of thinking of the needs of other ministry units as well as our own needs.

As I also said a year ago,

“The single most powerful signal of a change in the deployment of assets would be initiatives taken by individual parishes to give away surplus assets in order to developed focus, strategic mission in another part of the Diocese.”

I am delighted to report to you that some ministry units have been taking initiatives to give to other ministry units. Thanks be to God!

I have also been on record as saying that I see one of my tasks to encourage the lightening of the load of property on our Diocese. We have lots of properties. We will always need quite a bit of

property: churches, halls, vicarages. But every property we own represents both a financial and an administrative burden.

When the question of selling a property arises, especially a church which is no longer useful to the mission and ministry of a parish, I am likely to agree to the sale. One reason, which I have said before and I will say again, is that I do not see the new, younger generations of Anglicans as showing signs of wanting to administer lots of properties.

This past year, I am glad to report, has seen the sale of properties!

Royal Commission

A significant amount of work has occurred within our Diocese through the past year as the Royal Commission on Abuse of Vulnerable Persons has gotten into its stride. There has been research into files of past complaints. There has been work for the Diocese, for Anglican Care and for each of our Anglican Schools. The Commission has, as the months of 2020 have unfolded, made increasing demands on us to supply information. I thank all those involved in this work and acknowledge with gratitude the work of Wynn Williams, including our Chancellor, Jeremy Johnson, in collating information and engaging with the Commission on behalf of a collective of episcopal units, social services boards and Anglican schools, of which the Diocese of Christchurch is a part.

Good things in our Diocese

It was a very good experience, while we were not yet in Lockdown, to have two Churchwardens and Treasurers day conferences in March 2020. Prompted by a motion at last year's Synod, these conferences were well attended, well organized and received some great feedback. We will – Covid permitting – continue these conferences. We are also doing some thinking about a day Ministry Conference for training and encouraging all in ministry.

Our Anglican Schools – Christ's College, St Margaret's College, Craighead Diocesan School, St. Mark's, St. Michael's and The Cathedral Grammar – continue to provide opportunities for Christian teaching and witness, through chapel and classroom. I want to acknowledge the commitment of our Chaplains and the significant work of our Principals in responding to the special challenges of Lockdown this year.

We have Chaplains working in other spheres of life and work and I acknowledge all your ministries and pay tribute to your patience and endurance through the special circumstances of this year.

Good things in our Diocese are much, much more than this. I note, for example, the brilliant and generous response of many people to our two special appeals this year, for a general Pandemic Fund to support ministry units in the Diocese and even the Diocese itself as we face economic challenges due to the virus, and for a special situation, the Mirpurkhas Boys Hostel in Pakistan, also threatened financially because the virus has led to its usual sponsor withdrawing support.

Our life together

A huge number of people in our Diocese quietly get on with the tasks God has assigned to us. It is a privilege to meet so many of you, to talk about what God is doing among you, and then as bishop to leave your ministry unit, knowing that the work continues faithfully because of your responsibility and dedication to the work of Christ in the world.

The Covid 19 Pandemic

Permeating this Address and other presentations to Synod is the continuing Covid 19 Pandemic in our globe and in our nation and its effects on our mission and ministry operations.

Here I acknowledge with gratitude to God the wonderful way in which our Diocese has risen to the challenge of the Lockdown which began in March and more recently to a life in a resumed Level 2.

The Diocese of Christchurch and the world (2019-20) – Part B

Last year I drew attention to a theologian, Masure, who profoundly observed, in 1934, in the midst of a very troubling decade in human history that,

“Fundamentally the Gospel is obsessed with the idea of the unity of human society.”¹

A year ago I mentioned that contrary to a gospel vision for a unified human society, we had experienced the pain of the 15 March 2019 mosques massacres, the continuing divisive impact of President Trump on our world, and the ongoing menace on many levels of climate change.

A year later divisions due to Trumpian politics, terrible violence inflicted by human beings on one another and the threat of climate change remains. But we look back on a year in which, remarkably, there have been some moving and profound signs of human unity.

In relation to the tragedies of 15 March 2019, I note the moving way in which we united as a nation, just a few weeks ago to support Muslim brothers and sisters giving testimony at the sentencing of the terrorist. We have been further united in our complete and utter condemnation of the terrorist and in our shared conviction that a life sentence for this man must mean he is imprisoned until his final breath is taken.

Then, since January this year, as the world, including our own nation, has responded to the spread of Covid-19, we have seen in the midst of much virus induced division in the world around us, a remarkable period through the Lockdown of late March, April, May and early June in which we have been a “team of five million” Kiwis.

A few months later, as we have returned to Levels 2 and 3, some of that unity is fraying and the patient of many is being sorely tried, but let’s never forget the experience of being a united nation, determined to gain victory over the virus. Our journey into Level 4 and then down through Levels 3 and 2 to Level 1 in June has been a story of what we can do when we all want to paddle the waka in one direction.

Of course through the Lockdown earlier in the year, we paid a price as a nation in respect of economic pain, the sharpest edges of which were felt by the City Mission as its staff experienced unprecedented demand for food parcels and for other services.

Beyond the City Mission, as the whole year is looked back on, we see a wide range of ways in which Anglican Care has cared for our city and our province, including specific responses to the stress of the Pandemic on neighbourhoods. I want to thank Moka Ritchie, Chair of the Anglican Care Board, the Board, executive leaders including Matthew Mark, Patrick Murray, Roger Sutton (until end of January) and Jolyon White (Acting Anglican Missioner since January) and all their staff for their many commitments to serve others in the spirit of Jesus.

As I said a year ago, I want to say again this year,

“Every person we engage with through such ministries is our opportunity to be obsessed with the unity of human society, to be obsessed with bringing the reconciling ministry of Jesus Christ to the lives of the last, the least and the lost in our midst.”

We cannot leave this section without noting that 2020 is the year of two referenda, on the End of Life Choice Act and on the legalization of cannabis. The former, if approved, will see the Act approved by Parliament enacted; the latter, if approved, will see a highly regulated regime for the legal sale of cannabis proceed to consideration by a select committee. Both referenda are controversial and both have received some good consideration in our Diocese, especially through the work of Theology House and the Transitional Cathedral in organizing some first rate seminars on these matters.

2020 is also a year in which revision of legislation on abortion has been approved by Parliament. Much less controversial across the whole of our society these changes have not been beyond the concerns of many Christians who remain committed to the human right to live for the unborn child.

Mea Culpa – What have we not done in the past year? – Part C

I find it easy to forget what we said or resolved at the previous Synod! Perhaps you do too. I want to try to own up to areas in which we have not done what we said we would do, including areas in which I have not done what I said I would do. I mention three matters, though no doubt there are other sins of omission which could be named

1. **Strategic Goal:** A year ago I spoke about measuring how we are doing on Regeneration of the Diocese through this decade.

“Regeneration of the Diocese from 2019 -2030, measured by attendance numbers and by age profile of the Diocese, with reference to specific age surveys for the years, 2020, 2025 and 2030.”

Covid has affected our ability to embark on a measurement of both attendance numbers and to relate these numbers to an age profile of the Diocese. We will look again at this matter in 2021 but that re-look may involve determining that 2022 would be a better year in which to survey the Diocese.

2. **Climate Change:** last year at our Synod we resolved the following:

“MOTION 11: Climate Change & Ecological Emergency

That this synod, seeking to care for God’s creation and preserve a liveable earth:

- a. recognises a Climate & Ecological Emergency and seeks to act upon this truth,
- b. encourages other Dioceses of New Zealand / Aotearoa and Polynesia to do the same,
- c. asks Standing Committee/SLT to report back to synod 2020 via the Diocesan Manager, what actions have been taken in respect of the climate and ecological emergency,
- d. resolves to lobby local and central government to declare a climate and ecological emergency and act upon that truth, and

e. requires ministry units to seriously consider what actions they can take to:

I. mitigate the effects of climate heating & bio-diversity losses,

II. reduce our carbon footprint., and

III. to report back those actions to the Diocesan Manager who will provide a report of those actions at the 2020 Synod.

f. to assemble some resources/information to enable and empower ministry units to undertake appropriate action to reduce their carbon footprint.

Moved: Mr Arion Pons Seconded: Mr Neville Queen.”

The honest truth is that very little relative to the precise terms of the resolution has been achieved. However, some things have happened and I will note them here.

First, Standing Committee addressed the terms of the resolution in meetings in 2019 following Synod.

Secondly, we tried to get each ministry unit in the Diocese to appoint a “climate change champion” and report back to us who that person was. We received very little indication of ministry units making such appointments.

Thirdly, while the effects of Covid-19 meant we lost this resolution from Standing Committee’s agenda, there were other good effects in respect of climate change. Standing Committee is currently following a pattern of meeting face to face every second meeting and meeting via Zoom for its other meetings. CPT is trying the same regime and Anglican Care is proposing every third meeting is via Zoom. Other meetings in the Diocese are taking place by Zoom. And, in my experience, it is noticeable that meeting electronically is shifting us away from printing everything to do with our meetings on paper. (Our current Zoom Synod is also an example of this trend). Thus, in some measurable, practical ways, the Diocese is reducing its carbon footprint. It is also the case that nationally our church is doing more on Zoom and thus there is less flying around the country to get to meetings.

In sum: we have more work to do across our Diocese on combatting climate change and things certainly have not worked out according to the letter of this resolution but according to the spirit of the resolution I can report to you that some significant changes are taking place.

3. **Vicarage Design Review:** the request for this work, which included a report back to Synod, has not proceeded as we hoped. We still need to do this work but in at least one way, the delay in the work will lead to greater clarity about what we need to achieve. Events through this past year in respect of vicarages has highlighted the challenge of offering to ourselves a high standard for vicarages while real time engagement in various housing markets means we more often than not find ourselves unable within constraints of price and time to secure a house which meets that high standard.

Regeneration of the Diocese of Christchurch (2020-2030) – Part D

Introduction

Last year in my Presidential Address I began talk about Regeneration in this way:

“What kind of Diocese will we be in 2030?

Asking that kind of question helps us determine what we do in the years between now and 2030.

What kind of a Diocese could we be in 2030?

We could be healthy, happy and harmonious. And we should be. But that is a bit general!

My vision is that we are a **regenerated** Diocese – a Diocese regenerated through Christ.

Our statistics about decline in attendance, decline in baptisms, confirmations, weddings, and funerals are well known to us as Synod members.”

Last year I gave a table which this year is enlarged with 2018 figures:

	Total Attendance for worship in Dio Chch
2014	356,080
2015	351,448
2016	316,098 [a blip re counting?]
2017	336,155
2018	277,526
2019	258,623

The below par figures for 2018 and 2019 represent a number of parishes not making the statistical returns required of them. The figures for 2018 and more so for 2019 also represent a Diocese which has suffered disaffiliation of several congregations.

I also said this last year:

“Statistics are one thing, another is what we see with our eyes:

- I see a Diocese dominated by participants aged over 60 years.
- I see a Synod which represents that domination well

My vision is that in 2030 our eyes will tell us that the majority of our worshippers are aged under 60 years.

My vision is that in 2030 our statistics will tell us that we are growing again as a Diocese.

My vision is that in 2030 our testimonies will tell us that we have rediscovered ourselves as te Hāhi Mihinare, the missionary church.

The alternative in 2030 is that our eyes, our statistics and our hearts will tell us we are about to die. You do not want that. I do not want that. We do not want that future.”

So I set out before you a vision for a regenerated Diocese which paid attention to its understanding of its message, the gospel, and the importance being able to communicate the gospel effectively because we also understood that in the world today we need to be,

“a gospel church which is institutionally ethical, socially viable, personally effective and intellectually plausible.”

I underlined that

“Talk of regeneration is not about saving the Anglican club from closure.”

And I proposed that regeneration was about,

“re-discovering our purpose as New Zealand’s Missionary church.”

All such hopeful talk about a different future would struggle I observed because,

“Our cultural tendency is to look in on ourselves, to preserve what has been our way of doing things, and to focus on the needs of those who currently come to church.”

Thus I offered my vision for the Diocese of Christchurch in 2030 with this “snapshot”:

- a diocese in which God is glorified and the Gospel is proclaimed vibrantly in word and in deed, with its churches –all the churches – likely fewer in number than we have today - full on Sundays, with every generation represented in the congregations,
- and our multi-purpose buildings are busy Tuesdays to Saturdays with community serving activities and spiritual growth Bible study and fellowship groups;
- our cathedral in the Square is barely big enough for regular Diocesan youth services;
- Theology House has a staff of two full-time theologians, one of whom is a leading advocate for social, political and community issues of the day;
- there are several Anglican congregations in Christchurch city which no one is sure about where they meet because they keep moving but Facebook 3.0 keeps the networks informed.

Of course in 2020 that vision met the reality of Covid-19 as we faced being church online rather than in buildings and had to reconfigure our mission in our local communities in ways which did not involve physical gatherings of people.

I also noted to you that it was time to

“move on from talking about Christ-centred mission, raising up young leaders and faithful stewardship, though not because any of these three values are no longer important. They remain important but we need some refreshment and refocusing.”

Hence I introduced three new **Strategic Themes**:

DISCIPLES, FAMILIES, COMMUNITIES


I suggested if there were eight words to take away from the Address it was these:

“Regeneration through Making Disciples, Supporting Families, Strengthening Communities.”

A year later I remain convinced that Regeneration involves Making Disciples, Supporting Families and Strengthening Communities. Where we see Regeneration occurring in our ministry units we see these factors as work.

I also shared with you an **“Illustration of strategic themes”**

With respect to that illustration I observe that in various ways we have been able to strengthen our sense of partnership with Te Waipounamu and with ecumenical partners such as the Presbyterians and the Roman Catholics.



Resourcing Christ-centred Mission

Recognising, last year, that some sense of “**Strategic directions and values to guide decision-making in the Diocese and within its ministry units**” was needed, I offered the following:

“As a Diocese, when making decisions, we will:

1. Acknowledge that the local is connected to the universal and the universal is made up of the local: we walk and work together, ministry units and Diocese, towards regeneration of the ministry units of the Diocese.
2. Entrust decision-making, within constraints of civil and canonical law, to local faith communities.
3. **Ask ourselves (Vestry, Standing Committee, CPT Board, Anglican Care, Diocesan ministry Team, other Diocesan bodies), what will:**
 - a. **Make Disciples**
 - b. **Support Families**
 - c. **Strengthen Communities.**
4. **Repeat (3) as we make decisions about personnel, property and planning!!**
5. Bless thriving local churches and flourishing mission initiatives with practical support, thoughtful encouragement and public acknowledgment.
6. Strengthen weak local churches but always be willing to make change when, after a reasonable time period, strengthening has not yielded flourishing.
7. Acknowledge differences between rural and urban parishes (e.g. in respect of differing abilities to maintain property).
8. Acknowledge special situations in the Diocese, notably, the Chatham Islands, the West Coast parishes, Lyttelton and the Mission to Seafarers, the Transitional Cathedral, Rolleston, Hornby, Templeton and West Melton in relation to Wigram.
9. Offer, for a reasonable period, intense “life support” for the parishes most affected by disaffiliations in 2018-19.
10. Take account of short term needs (1-2 years), medium term considerations (5-6 years), and long-term strategic value (2030).
11. Be open to new arrangements for parishes and archdeaconries so that we support ministry to local communities across the rural districts and urban areas of our Diocese.
12. Invite generosity from ministry units as they support other ministry units.
13. Nevertheless be open to synodically and consensually determining aspects of resource sharing.
14. Encourage new initiatives in mission and ministry and acknowledge the possibility of risk to current ventures when new things happen.
15. Continue support for and engagement with ministry units which have chaplains: schools, hospitals, residential care facilities, universities, armed forces, emergency responders, police.
16. Favour co-operation where this is either locally desired or become necessary, especially with Presbyterian and Roman Catholic churches, while always supporting identity and strengthening accountability.
17. Lighten the property portfolio of the Diocese which is held in trust by the Church Property Trustees, acknowledging that a regenerating Diocese is unlikely to increase the number of administratively minded Anglicans, by encouraging parishes to reduce their holdings of churches, halls and houses.”

While this document remains important to me, it is more important for the Diocese, especially for the CPT Board and for Standing Committee that we have a document which the Synod has adopted to guide decision-making, especially in respect of “big ticket” items which beg questions about the strategic context in which they should be considered.

Hence at this Synod we have a motion which, if resolved, will lead to the establishment of a working group to develop a draft Diocesan Mission Action Plan with a view to this draft being presented to Synod in 2021 for adoption by the Synod.

I want to make a few remarks about what a **Diocesan** Mission Action Plan means.

1. It must be a plan we agree to by majority in our Synod.
2. It cannot be a plan which cannot command a majority even if it accords with the smartest mind in the room or with the edgiest thinker in the precinct.
3. For CPT or Standing Committee or any other entity in the Diocese to act according to a Diocesan Mission Action Plan, it needs the authority of Synod in doing so.
4. Otherwise a ministry unit can ask, in words familiar from one of the gospel stories, “By what authority do you act?”
5. Thus a particular challenge for the working group will be to listen carefully to voices from across the whole Diocese and to discern what the mind of our Synod is likely to be in September 2021.
6. There is no expectation on this working group that they will travel widely across the Diocese, spending hours and hours on the road and even more hours in meetings. That approach would require time and energy that few of us have, and might well hold the process back for an extra year.
7. It is an expectation of the working group that there will be smart ways of listening to the Diocese, for instance through surveys, phone calls, Zoom meetings with representatives from the different Archdeaconries, as well as conversations with our younger generations – the generations which will carry the Diocese forward from 2030.
8. Finally, if we had been able to meet face to face, we would have had a good hour in small groups on the second day of our Synod business sessions. We do not have that opportunity this year, which is a pity but is also the way things are.

Two announcements about the immediate future

1. I am working on a new position on the Diocesan Ministry Team which will focus on the cause of Regeneration of our Diocese: a “Consultant on Regeneration” though likely the position will have a different title to that phrase. I hope we can begin advertising for this position soon and make an appointment effective from early 2021.
2. I am very pleased to announce to the Synod that we have secured a new location for the Anglican Centre. This new location is Cardale House, a property belonging to the Parish of Christchurch St Michael’s. It is on Tuam Street, just around the corner from Durham Street. Some strengthening work is required on the building and there will be some fit out. Our hope is that we can move from Logistics Drive mid 2021, and certainly by the end of October 2021.

From 1989 to 1997, Graeme held Permission to Officiate in various positions in Australia and the U.K. On his return to Christchurch in 1997, Graeme was granted Permission to Officiate and served as Clerical Canon (1997-2005) and Chaplain to the Community of the Sacred Name (1997-2011). Graeme was granted Permission to Officiate in the Diocese of Nelson on his move there in 2016. Graeme died in Nelson on August 20, 2020 at the age of 79.

The Reverend Antony John (Tony) Courage was born in 1938 and died in Oxford, North Canterbury on Saturday 28 September 2019. Tony was ordained deacon in 1971 and priested in the same year, serving initially in the Canadian Anglican Church. In the Diocese of Christchurch he served in the parishes of Geraldine (1975-77) Ashburton (1977-78), Oxford (1978-81), Ellesmere (1981-82), Kaiapoi (1982-89) New Brighton (1989-98) and then, while living in retirement in Oxford, assisting with ministry in the Oxford-Cust Parish.

The Venerable Frederick John Ford was born in 1926, and died at the age of 93 on 8 November 2019 in Christchurch. John was ordained deacon in 1949 and priested the following year in Nelson. John initially served in Nelson before spending time in Rarotonga in 1960-61 as a chaplain. After returning to New Zealand, John continued to serve in the Nelson Diocese, including being appointed Archdeacon for Marlborough 1971-1989 and Vicar General for Nelson Diocese 1975-1989. When John retired in 1989, he was granted Archdeacon Emeritus status and Permission to Officiate. After retiring, John moved to Christchurch, where he continued to serve as an Officiating Minister.

The Reverend Shirley Greenwood was born in 1924 and died in Christchurch in her 96th year on 27 July 2020. Shirley was ordained deacon in 1982 then priest in 1983, and served in the Parish of Sumner-Redcliffs as an Assistant Priest 1982-1989. Shirley was granted Permission to Officiate in 1989.

The Reverend Paul Drew Heard was born in 1950 and died on Tuesday 17 March 2020 at the age of 69. Paul was ordained deacon in 1985 and priested the following year in Christchurch. Paul served in the parishes of Rangiora (1986-87), Waihao Co-operating Parish (1987-91) and Sumner-Redcliffs (2003-09). Paul was then granted Permission to Officiate in the Diocese of Christchurch.

Earle and his wife Elspeth went on to serve in the Parish of Addington as part of the Local Shared Ministry Team in 2009.

CORONAVIRUS/COVID-19 LOCKDOWN

Timeline:

- 31 January 2020** World Health Organisation declared a new type of Coronavirus, that had spread from an outbreak in a Wuhan, China seafood market in early December, a “public health emergency of international concern”.
- 3 February** NZ Government placed entry restrictions on foreign nationals travelling here from, or transiting through, mainland China. Those who can enter the country must self-isolate for 14 days.
- 28 February** First case of COVID-19 was reported in NZ
- 2 March** NZ Government announced 14 day self-isolation for anyone who had visited who had visited northern Italy and South Korea
- 11 March** WHO declared an official pandemic
- 13 March** Ministry of Health Advice specific to churches was issued:
“All faith communities should ensure that the practices that they use do not put their community at risk. In particular, we do not recommend sharing of

communion cups, or shared dipping of hands in holy water. People who are unwell should not attend, and should avoid personal contact such as shaking of hands. Faith communities can play a role in supporting people and assist with practicing and disseminating evidence based health advice to help keep their communities safe such as through hand hygiene, social distancing and cough etiquette. COVID-19, like the flu, can be spread from person to person. When a person who has COVID-19 coughs, sneezes or talks, they may spread droplets containing the virus a short distance, which quickly settle on surrounding surfaces. You may get infected by the virus if you touch those surfaces or objects and then touch your mouth, nose or eyes. The Ministry's advice on the best way to protect yourself and others is available on our website. And this will be updated regularly with new information as it comes available/relevant."

- 14 March** NZ Government announced that anyone entering the country must self-isolate for 14 days; Memorial services for the Christchurch terror attacks of 15 March, 2019 were cancelled.
- 16 March** Coronavirus Guidelines were issued from Bishop's Office, including instructions concerning Communion under one kind only; no shaking hands or hugging; handwashing; extra cleaning; instructions for Baptism, Confirmations, Chrism/oil, hospitality, pastoral care, church activity groups;
- 19 March** NZ government closed the country's borders to all but New Zealand citizens and permanent residents

SUSPENSION OF ALL SERVICES OF PUBLIC WORSHIP On the twentieth day of March 2020

Bishop Peter Carrell issued the following guidelines:

Following the announcement by the government of restrictions in size of gatherings, the bishops of the Anglican Church in Aotearoa, New Zealand and Polynesia have agreed to issue the same instruction to all clergy and parishes: until further notice, all services of public worship in our churches are suspended from Monday 23 March 2020.

All AGMs not yet held in parishes, from Monday 23 March are to be postponed until it is permissible to meet again.

Funerals and weddings are in the nature of public services and are subject to the suspension of all services of public worship

All Easter services are included in the suspension of services of public worship.

- 21 March** The Government introduced a 4-level alert system and declared that New Zealand was at Level 2
- 22 March** Online streaming of services began in some churches.
- 23 March** The Government announced that community transmission was occurring - NZ moved to Level 3; People are instructed to stay at home.

- 24 March** State of Emergency was declared, and the country went into Level 4 lockdown at midnight
- 27 April** Alert Level reduced from 4 to 3 at 11.59pm
- 11 May** The Government announced a limit of 10 for Church gatherings in Level 2
- 12 May** Bishop Peter released guidelines for services in Level 2
- 13 May** New Zealand began move from Alert Level 3 to 2 from 11.59pm
- 14 May** Bishop Peter issued the following guidelines:
In the light of the NZ Government's announcement yesterday re the limits to funerals being raised to 50 (providing certain conditions are met), and after consultation with other bishops and with our Senior Leadership Team, the following are our Diocesan Guidelines for Funerals at Level 2 (until further notice such as change in Government rules):
1. The Transitional Cathedral or any parish church may be used for funerals of up to 50 people provided all Government and Diocesan Guidelines are followed in respect of safe gatherings of people (including cleaning of church, availability of sanitizer, recording of contact details).
 2. In particular any funeral for a gathering between 10 and up to 50 persons may only take place if the Funeral Director associated with the funeral registers the service with the Ministry of Health and otherwise complies with all Government funeral guidelines as announced on Wednesday 13 May 2020.
 3. Until further notice, the seating for each member of the congregation gathering for a funeral should be pre-arranged in such a manner that each person is seated 2m away from the next person (in every direction of the compass).
 4. Hymn singing at a funeral service may take place but the seating arrangement in 3 above must be strictly followed to minimise risk of transmission of the virus.
 5. Any clergyperson unsure whether these guidelines can be followed in their local church because of the size and/or seating layout is encouraged to consider use of a funeral director's chapel or other, larger church venue nearby.
 6. Any clergyperson unsure about any aspect of conducting a funeral safely at Level 2 is encouraged to consult with their Archdeacon.
 7. Chaplains must abide by any guidelines set down by their employing institution, even if those guidelines conflict with these guidelines.
 8. A reminder that the limit on people gathering for any other religious service or meeting of the church, inside or outside, is 10 (with review of this limit to be announced by the Government on 25 May 2020).

- 25 May** Government announces that from noon on Friday 29 May 2020 the limits on gatherings, including church services, funerals, memorial services, lift from 10 to 100. Bishop Peter issued updated guidelines.
- 26 May** Alternative one-day Clergy Conference is held by Zoom
- 8 June** New Zealand steps down to Level One, with continuing border restrictions, advice to continue health and safety and contact tracing measures.
- 9 June** Bishop Peter issued guidelines for Level One

**BILL 1: THE BISHOPRIC ESTATE INCOME AUGMENTATION STATUTE
REPEAL BILL 2020**

1. Title

That the title of this statute will be **The Diocesan Synod Statute Amendment Bill 2020**

2. Commencement

This Statute comes into force at the end of the session of Synod at which it is passed.

3. Purpose

The purpose of this Statute is to amend the Diocesan Synod Statute to confirm the ability of the Synod to meet remotely and to allow for elections of Standing Committee to take place when Synod is meeting remotely.

4. Amendment to clause 4.1

Clause 4.1 of the Diocesan Synod Statute is amended by the addition of the following words at the end of the first sentence *“which, for the avoidance of doubt, includes meeting by Zoom or other similar video conferencing facility.”*

5. Amendment to clause 5.4

Clause 5.4 of the Diocesan Synod Statute be amended by the addition of a new subclause 5.4.8 as follows:

“5.4.8 Whenever Synod is meeting by Zoom or other similar video conferencing facility then elections for Standing Committee shall take place in accordance with the Standing Orders adopted for that meeting.”

1. Title

That the title of this statute will be **The Bishop’s Pension Fund Statute Repeal Statute 2020.**

2. Commencement

This Statute comes into force at the close of the session of Synod at which it is passed.

3. Purpose

The purpose of this Statute is to repeal the Bishop’s Pension Fund Statute as it no longer has any purpose.

4. Repeal

The Bishop's Pension Fund Statute is repealed.

BILL 6: The Ethical Conduct and Complaints Procedures of the Diocese of Christchurch Repeal and Replacement Bill 2020

1. Title

The title of this Statute is The Ethical Conduct and Complaints Procedures of the Diocese of Christchurch Repeal and Replacement Statute 2020.

2. Commencement and transition

This statute comes into force on the commencement of Statute 753 passed at the 25 July 2020 session of the General Synod/Te Hinota Whanui.

All complaints received prior to the commencement of this Statute will be resolved in accordance with The Ethical Conduct and Complaints Procedures of the Diocese of Christchurch Statute 1995 in force at the time the complaint was received.

3. Purpose

The purpose of this Statute is to repeal and replace The Ethical Conduct and Complaints Procedures of the Diocese of Christchurch Statute 1995 to reflect the changes made to the ministry standards and complaints provisions of Title D of the Canons of this Church in Statute 753 passed at the 25 July 2020 session of the General Synod/Te Hinota Whanui.

4. Repeal and replacement

The Ethical Conduct and Complaints Procedures of the Diocese of Christchurch Statute is repealed and replaced with the provisions set out in the Schedule.

Schedule

The Complaints Procedures of the Diocese of Christchurch Statute

PART 1 – PURPOSE AND INTERPRETATION

1. Title

The title of this Statute is The Complaints Procedures of the Diocese of Christchurch Statute 2020.

2. Purpose

The purpose of this Statute is to provide the process to be followed by the Diocese of Christchurch when complaints of unsatisfactory conduct are referred to the Bishop of the Diocese of Christchurch, as Licensing Bishop, for resolution under Title D Canon III of the Canons of this Church.

3. Interpretation

(1) In this Statute, where applicable and unless the context otherwise requires, words have the same meaning as given to them in Title D Canon I.

(2) In this Statute, unless the context otherwise requires:

- a. “Church” means the Anglican Church in Aotearoa, New Zealand and Polynesia;
- b. “Civil Agencies” means the Police, Civil Courts, Human Rights Commission, Employment Tribunal, or any other body have jurisdiction under laws of New Zealand in respect of complaints;
- c. “Clergy” means all Ordained Ministers;
- d. “Diocese” means the Diocese of Christchurch;
- e. “Inter Diocesan Conference” means the governing body of the New Zealand Dioceses;
- f. “Lay Workers” means any non-ordained person employed by the Diocese or a Local Ministry Unit whether or not they are licensed or unlicensed or paid or unpaid;
- g. “Ministry Unit” has the same meaning as in the Diocesan Ministry Units Statute 2020;
- h. “Monitor” means the monitor appointed pursuant to clause 10;
- i. “Monitoring Committee” means the committee appointed pursuant to clause 6; and
- j. “Support Person” means those persons appointed in accordance with clause 15.

PART 2 – MONITORING COMMITTEE

4. Monitoring Committee

The Monitoring Committee in existence at the time of commencement of this Statute shall continue in existence.

5. Membership of the Monitoring Committee

- (1) The Monitoring Committee shall consist of between three and five persons, who are members of this Church, and recognising the need for diversity be appointed by the Standing Committee.
- (2) Members of the Monitoring Committee are appointed for two years at which point they cease to hold office unless reappointed for a further term.
- (3) Members of the Monitoring Committee may resign by giving written notice to the Bishop.
- (4) The Standing Committee may remove any member of the Monitoring Committee at any time.
- (5) The powers and functions of the Monitoring Committee shall not be affected by any vacancy in its membership.
- (6) The Monitoring Committee will appoint one of its number to be the Chair.

5. Functions and powers of the Monitoring Committee

- (1) The functions of the Monitoring Committee are:
- a. to recommend to the Bishop a person or persons for appointment as Monitor;
 - b. to arrange appropriate training for a Monitor;
 - c. to oversee and supervise a Monitor;
 - d. to advise and assist a Monitor;
 - e. to appoint Support Persons where appropriate and assist in training them;
 - f. to advise and assist the Bishop and Standing Committee on all aspects of the Diocesan processes relating to complaints;
 - g. to assist the Diocese to provide appropriate training and compliance programmes in respect of Title D, ministry standards and complaints;
 - h. to promote an understanding of Title D, ministry standards and complaints.
- (2) The Monitoring Committee shall have such powers as are reasonably necessary to enable it to carry out its functions provided that it cannot expend any funds except those allocated to it in the Diocesan budget,

6. Reimbursement of Expenses

Members of the Monitoring Committee shall be paid any such allowances and be reimbursed any expenses as allowed for, from time to time, in the Financial Regulation of the Diocese.

7. Meetings of the Monitoring Committee

- (1) The Chair will convene meetings of the Monitoring Committee as necessary for efficient performance of its functions provided it must meet at least two times each year.
- (2) A meeting may be called by any two members of the Monitoring Committee.
- (3) Meetings may be conducted in person or via video conferencing.
- (4) At least 10 working days' notice of any ordinary meeting must be given. If in the view of the Chair, an extraordinary meeting to respond to a matter of urgency is required, it may be called at short notice.
- (5) The chair will preside at meetings of the Monitoring Committee or, if the chair is absent, another person elected by those present at the meeting.
- (6) The quorum for a meeting of the Monitoring Committee is three members.
- (7) The Monitoring Committee shall ensure minutes of its meetings are kept.

PART THREE - MONITOR

Appointment of Monitor

- (1) The Bishop shall appoint a Monitor on the recommendation of the Monitoring Committee and in consultation with Standing Committee.

- (2) The Bishop may appoint more than one Monitor.
- (3) A Monitor is appointed for a term of three years and may be reappointed.
- (4) The Bishop may remove a Monitor at any time.
- (5) A Monitor may resign by giving written notice to the Bishop.

10. Functions of the Monitor

- (1) The functions of the Monitor or Monitors are to:
 - a. process complaints referred to a Monitor by the Bishop in accordance with this Statute;
 - b. arrange counselling for the Complainant if appropriate;
 - c. monitor complaints dealt with by Civil Agencies;
 - d. keep the Monitoring Committee and Bishop informed of complaints;
 - e. keep a file in respect of each complaint which shall be confidential to a Monitor and the Bishop;
 - f. assist in providing support for:
 - I. any complaint and the complainant's family;
 - II. any respondent and the respondent's family; and
 - III. the Local Ministry Unit;
 - g. assist the Diocese to set up training and compliance programmes in respects of Title D, ministry standards and complaints; and
 - h. assist in the training of Support Persons.
- (2) A Monitor is responsible for the selection of facilitators to handle complaints where appropriate.

11. Qualifications of the Monitor

- (1) A Monitor must:
 - a. have an understanding of the ethos of the Church;
 - b. have appropriate training and experience relating to professional or ministry standards;
 - c. have appropriate understanding of, and training in, complaints processes.
- (2) A Monitor must undertake regular professional supervision.
- (3) On appointment a Monitor must complete the declaration set out at clause C15 of Te Pouhere/the Constitution.

12. Remuneration of the Monitor

- (1) A Monitor may be paid such remuneration by way of fees, salary, or wages as decided by the Standing Committee.
- (2) A Monitor may be paid such allowances and expenses (including expenses for professional supervision) as are provided for in the Financial Regulations of the Diocese.

13. Powers of the Monitor

- (1) A Monitor shall be subject to the authority of the Bishop who may review the Monitor's functions and duties as necessary.
- (2) The Monitor shall have all such powers as are reasonably necessary to carry out the Monitor's functions and duties provided that the Bishop may prescribe the powers of the Monitor as necessary.

PART FOUR – SUPPORT PERSONS

14. Appointment of Support Persons

- (1) The Monitor or Monitors shall keep a list of trained Support Persons.
- (2) A Monitor shall provide the list of trained Support Persons to the complainant, respondent, their families, and the Local Ministry Unit once a complaint is referred to that Monitor.
- (3) Where a complainant or respondent or Local Ministry Unit engages a Support Person, the Monitor concerned should be notified of the name and contact details of the person appointed.
- (4) Complainants, respondents, and their families retain the right to consult whosoever they wish for support.

15. Training of Support Persons

- (1) Support Persons shall be trained:
 - a. to provide appropriate support to those involved in complaints processes;
 - b. to understand the process for resolution of complaints under Title D and this Statute.

PART FIVE - COMPLAINTS

16. Application of this Part

This Part applies to any complaint of unsatisfactory conduct where the Registrar recommends, pursuant to Title D Canon III clause 23(a), the Bishop resolves the complaint.

17. Complaint process

- (1) On receipt of a written report under clause 22 of Title D Canon III recommending, pursuant to Title D Canon III clause 23(a), that the Bishop resolves a complaint of unsatisfactory conduct, the Bishop shall provide a copy of the report to a Monitor.

- (2) The Bishop shall then either:
- a. direct that Monitor to conduct a process of reconciliation under clause 18;
 - b. direct that Monitor to conduct an investigation under clause 19; or
 - c. direct the respondent to receive further counselling pursuant to Title D Canon III clause 33.

18. Process of reconciliation

- (1) Where a Monitor is directed to conduct a process of reconciliation, that Monitor may:
- a. facilitate meetings between the complainant and respondent as that Monitor thinks fit;
 - b. appoint an independent facilitator as that Monitor thinks fit; or
 - c. otherwise conduct the process as that Monitor thinks appropriate.
- (2) A Monitor shall keep the Bishop updated as to the progress of any process of reconciliation.
- (3) Any outcome agreed between the complainant and respondent is subject to the agreement of the Bishop.
- (4) If there is no agreed outcome, the matter is to be referred back to the Bishop who must then direct an investigation under clause 19.
- (5) At the end of any process of reconciliation the Monitor engaged in the process shall:
- a. record the outcome in the complaints file;
 - b. close the complaints file; and
 - c. notify the Registrar and the Monitoring Committee of the outcome.
- (6) In conducting a process of reconciliation, the Monitor must follow any applicable guidelines issued by the Ministry Standards Commission.

19. Process of investigation

- (1) Where a Monitor is directed to conduct an investigation then:
- a. the Monitor must provide written notice of that to the complainant and respondent;
 - b. the Monitor must obtain from the complainant an outline of the complaint and supporting evidence;
 - c. the Monitor must put all allegations to the respondent and obtain from the respondent a response to the complaint and supporting evidence;
 - d. the Monitor may make such enquiries of possible witnesses as the Monitor thinks fit; and
 - e. the Monitor must prepare a written report to be provided to the complainant, respondent, the Monitoring Committee, and the Bishop outlining the outcome of the investigation and recommend actions including further training or counselling or admonition.

- (2) In conducting an investigation, a Monitor may have regard to any evidence which the Monitor considers is of probative value.
- (3) In conducting an investigation, a Monitor must follow any guidelines applicable to such an investigation issued by the Ministry Standards Commission.

20. Outcomes

- (1) On receipt of a report of an investigation under clause 19 where unsatisfactory conduct is established the Bishop may:
 - a. admonish the respondent pursuant to Title D, Canon III clause 54(a); and/or
 - b. require the respondent to undertake further training or counselling.
- (2) The Bishop is not bound to follow the recommendations of a Monitor and may seek advice from the Registrar or Ministry Standards Commission as to an appropriate outcome.

21. Referral to the Registrar

Where, during the course of handling a complaint under this Statute, the conduct complained of would, if proven, constitutes misconduct then the process under this Statute must immediately cease and the matter be referred to the Registrar in accordance with Title D, Canon III clause 17.

MOTION 10: Unzipping Of Parish Of East Christchurch Into Two Districts And Joining One District With The Parish Of Shirley

Preamble:

1. The Parish of East Christchurch came into existence as an amalgamation of the Parishes of Burwood, New Brighton and North New Brighton on 1 November 2014, following a Synod resolution at the Fourth Session of the Fifty-Second Synod of the Diocese of Christchurch (2014).
2. The Parish of Shirley suffered a significant loss of active parishioners when over 90% voted in 2018 to disaffiliate from the Diocese of Christchurch.
3. Ministry developments in the Parish of East Christchurch since 2014 and in the Parish of Shirley since 2018 have led to a proposal, first, to unzip the Burwood and Marshland district from the district of New Brighton and North New Brighton, and, secondly, to join the Parish of Shirley to the district of Burwood and Marshland.
4. The pathway to the motion below includes:
 - a. the AGM of the Parish of East Christchurch, 24 March 2019: unanimous motion authorizing the commencement of the process of unzipping the parish into two parishes;
 - b. the vestry of the Parish of East Christchurch, 28 November 2019, endorsing the Memorandum of Understanding on the proposed boundary changes between East Christchurch and Shirley and the de-merger of the ministry units of (i) Burwood and Marshland and of (ii)

North New Brighton and New Brighton;

- c. the “Memorandum of Understanding Anticipating a Boundary Change for Greater East Christchurch”, 04 November 2019, signed by the Bishop of Christchurch, the Vicar of East Christchurch, the Priest in Charge of Shirley, the Churchwardens of East Christchurch and the Churchwardens of Shirley
- d. the AGM of the Parish of East Christchurch, 16 February 2020, which adopted the reports of the Vicar and Vicar’s Warden thus supporting the intent of the MOU of 04 November 2019.
- e. the AGM of the Parish of Shirley, 23 February 2020, which unanimously adopted a motion accepting the rights and responsibilities for the congregational life of Burwood and Marshland including all costs associated with all land and properties of Burwood and Marshland.

Motion:

1. That this Synod, pursuant to the Diocesan Local Ministry and Mission Units Statute, section 3.4 (“The boundaries of any parish may be altered by Synod on the request of the Vicar or Ministry enabler in Local Shared Ministry Parishes, Churchwardens and Vestry of the parish concerned or an adjoining parish ...”) agrees to the boundaries being changed between the Parishes of Shirley and of East Christchurch such that:
 - a. The Parish of Shirley is enlarged in geographical territory to include the districts of Burwood and Marshland (that is, to include the territory of the Parish of Burwood as at 31 October 2014).
 - b. The Parish of East Christchurch is reduced in geographical territory to exclude the districts of Burwood and Marshland (that is, to exclude the territory of the Parish of Burwood as at 31 October 2014).
 - c. All property within the districts of Burwood and Marshland becomes property of the enlarged Parish of Shirley.
 - d. All trusts held by CPT on behalf of the districts of Burwood and Marshland be held by the CPT on behalf of the enlarged Parish of Shirley.
 - e. All property within the North New Brighton and New Brighton districts of the Parish of East Christchurch remains the property of East Christchurch.
 - f. All trusts held by CPT on behalf of the North New Brighton and New Brighton districts of the Parish of East Christchurch, or otherwise held on behalf of the Parish of East Christchurch (excluding those referred to in D above) be held by the CPT on behalf of the Parish of East

Christchurch.

- g. All operational finances of the Burwood and Marshland district, as set out in the “Memorandum of Understanding Anticipating a Boundary Change for Greater East Christchurch” (04 November 2019, signed by the Bishop of Christchurch, Vicar of East Christchurch, Priest in Charge of Shirley, Churchwardens of East Christchurch, Churchwardens of Shirley) be transferred to the enlarged Parish of Shirley.
- h. All other operational finances of the Parish of East Christchurch as set out in the “Memorandum of Understanding Anticipating a Boundary Change for Greater East Christchurch” (04 November 2019, signed by the Bishop of Christchurch, Vicar of East Christchurch, Priest in Charge of Shirley, Churchwardens of East Christchurch, Churchwardens of Shirley) excluding those referred to in G above remain held by the Parish of East Christchurch.

MOTION 16: Distribution of Insurance Surplus

Moved: That this Synod:

1. acknowledges it was informed in 2018 of the existence of an insurance surplus in respect of 2010/2011 earthquake insurance claims;
2. acknowledges it was informed in 2019 that the determination of a fair distribution of the surplus was taking longer than expected due to the complexity of establishing a sound legal basis for distribution;
3. acknowledges that the insurance surplus in 2020-21 is enabling the Church Property Trustees to complete recovery projects whose costs have proved higher than the assessments made when the insurance settlement was negotiated in 2013;
4. notes that after reservation of surplus insurance funds for estimated costs of completion of the remaining recovery projects, a residual surplus will remain for distribution;
5. notes that after communication between the Church Property Trustees and Standing Committee, including consultation with legal advisers, the two committees decided on a joint approach to the distribution so that the residual surplus will be distributed on the following basis:
 - 5.1. the surplus will be held:
 - 5.1.1. as it relates to contents, for the purposes of the ministry units that owned the contents;
 - 5.1.2. as it relates to the Insured Properties, on the same trusts as the land and buildings to which the claims relate;
 - 5.2. the surplus will be allocated to all land and buildings and contents where claims arose; and
 - 5.3. divided proportionally on the basis of the value of the policy entitlements of each claim. For the total losses, the entitlement calculation will be the amount paid out (which was the sum insured). For the repair projects, the entitlement calculation will be the final cost of repair
6. notes that this approach is supported by ChristChurch Cathedral Reinstatement Ltd and the ChristChurch Cathedral Reinstatement Trust;
7. notes that CPT, with the agreement of Standing Committee, has decided to apply to the High Court for approval for the distribution as agreed between it and Standing Committee with the Bishop, on behalf of the Diocese and its ministry units, and the Attorney-General, to be parties;

8. supports this process as decided by the Church Property Trustees and Standing Committee;
9. and encourages Bishop Peter to write to the vicars/priests-in-charge and churchwardens of the ministry units, seeking commentary on this process so that he is able to represent the views of the ministry units in the High court.

Motion Put

MOTION 11: Synod Motion re Property and Finance

Preamble: *This motion acknowledges:*

- *discussions in previous Synods and past work by CPT and SC to seek funds from ministry units for Diocesan ministry and missional purposes;*
- *a variety of appeals over time to the Diocese from ministry units requesting assistance;*
- *some ministry units enjoy financial blessings when other ministry units are financially hard pressed (2 Corinthians 8:13-15);*
- *a few ministry units have property that is effectively in a land bank and, in the past, some have gone into property overdraft;*
- *the Diocese only has about \$300k available for missional purposes (in the Bishop's Mission Fund and other funds that are controlled by Standing Committee and/or the ADMSC Board);*
- *Church Property Trustees holds no funds "of its own" that could support either missional purposes or purchase new property;*
- *Church Property Trustees has regularly informed Synod over many years that it considers the three estates—General Trust Estate, Bishopric Estate and the Dean and Chapter Estate—have insufficient capital to continue supporting, respectively, the Diocesan budget, the costs of the Bishop's ministry and office, and the mission and ministry of the Cathedral.*

MOVED: That This Synod resolves as a matter of Diocesan guidelines that

Part One: every ministry unit in the Diocese of Christchurch:

1. receiving funds by way of a bequest, substantial gift, having taken into consideration the conditions of the bequest or gift, or sale of property or surplus from sale of a property which is replaced by a like property (e.g. replacing one vicarage with another) will consider gifting at least a tithe of these funds to one of three purposes listed in (5) below;
2. in possession of funds held for general purposes or for purposes no longer applicable in the life of the ministry unit annually considers gifting at least a tithe of these funds to one of three purposes listed in (5) below;
3. in possession of property which is either not used or under-utilised in the mission and ministry of the ministry unit will annually consider such property

with a view to either better using the property or to selling the property, with funds generated by any such sale to then be considered in terms of (1) above;

4. in possession of more than one church or hall or vicarage will annually review such multiple properties, asking itself whether the cost of continuing possession is sustainable in respect of the mission action plan of the ministry unit, and where determined, seeks approval to sell such properties, with funds generated by any such sale to then be considered in terms of (1) above;
5. Giving from ministry units with reference to (1) to (4) above is encouraged with gifts made to:
 - a. A specific Diocesan fund which is held for the purpose of developing mission and ministry in the Diocese of Christchurch
 - b. A neighbouring ministry unit, or to other ministry unit of the Diocese of Christchurch, in consultation with the Bishop;
 - c. A mix of a. and b. as determined by the ministry unit making the gift.
6. Notwithstanding (5) above, ministry units may choose to give to the three estates held in trust by the Church Property Trustees.

Part Two: Standing Committee, Church Property Trustees and the ADMSC Board:

1. Will view favourably the request of ministry units to gift funds where those funds are determined to be surplus to local requirements, even where those funds otherwise relate to property; providing that,
2. Each ministry unit (other than non-territorial ministry units) retains at least one church, one hall (or one church-and-hall complex), and one vicarage (or funds in hand to purchase a vicarage within the territory of the ministry unit).

MOVED: That the Synod approves the following process towards the presentation and adoption at Synod 2021 of a Diocesan Mission Action Plan to guide decision-making in the Diocese of Christchurch, 2021-2030:

- A working group will draft a Diocesan Mission Action Plan by 31 May 2021 for circulation with Synod papers prior to Synod 2021.
- The working group will propose the draft Diocesan Mission Action Plan (if necessary, as amended after pre Synod meetings) to Synod 2021 with a view to it being adopted.
- In drafting the Diocesan Mission Action Plan, the working group will attend to the strategic vision of a regenerated Diocese.
- The working group will consult with Bishop Peter in the course of its deliberations including a near final draft of the Plan prior to circulation in Synod papers.

- The working group will have secretarial support as arranged with the Diocesan Manager and the cost of this support will be a cost to the Diocesan budget for 2020 and 2021.
- The working group will consist of 6 persons appointed by the Standing Committee at the October meetings.

MOTION 12: Diocesan Quota Review

Preamble: *This motion acknowledges:*

- *In general terms the setting of quota for each ministry unit as an assessment of contribution towards the Diocesan budget is a challenging matter;*
- *Through history and across NZ dioceses, differing formulae have been used, without any sense that there is one formula which is definitively superior to other formulae;*
- *The current formula for the Diocese of Christchurch was set a few years ago, after significant review, and incorporated features which were well intended but which arguably have consequences viewed unfavourably;*
- *A specific complaint is that setting the formula in relation to income leads in some cases to significant changes to quota for a ministry unit because in some years a ministry unit's income varies considerably and somewhat unpredictably (e.g. receiving a bequest);*
- *By contrast, the Diocesan budget changes little from year to year; the "effective cost" of ministry units being served by the Diocese also changes little from year to year, so a greater consistency in quota for each ministry unit from year to year should be achievable;*
- *A further concern at this time re the current formula is that while an intention to assist ministry units with multiple properties with a rebate is laudable, a consequence of doing so is that such ministry units are not*

being encouraged to actively review their properties and whether they can afford to retain them all.

MOVED: That this Synod requests that:

1. The ADMSC Board and Diocesan staff review the diocese quota for 2021 with a view to minimising change in quota from 2020 to 2021, even if this involves some consultation with ministry units in order to secure agreement to vary the application of the current formula.
2. Standing Committee appoint a Quota Working Group (which must include at least one lay or clerical member from a rural ministry unit with multiple properties) to rapidly review the current Quota formula and bring a revised formula to Synod 2021 for implementation for the years from 2022 onwards.
